#### PRESIDENTS REPORT TO THE 2012 AGM

Since the last AGM, the Association has continued its successful model of conducting Canberra Seminar Luncheons inviting prominent speakers to address matters of relevance to the RAAF today. We have enjoyed the Joint Patronage of AIRMSHL Mark Binskin, now Vice Chief of the Defence Force and of AIRMSHL Geoff Brown, Chief of Air Force. Both have been supporters of the Association for many years in their previous ranks and roles. AIRMSHL Brown spoke to us at our March 2012 luncheon, and in July AVM Margaret Staib, Commander Joint Logistics informed us of the Joint Logistics Transformation Project. On 4<sup>th</sup> October our guest speaker, AIRCDRE Warren McDonald, Director General Capability Planning—Air Force, will speak on 'UAVs and the RAAF/ADF'. All speakers are chosen to bring to Association members interesting and topical matters, and we expect there will many such matters to choose from in 2013.

You may have already visited the RAAF's Hughie Edwards VC Memorial Grove in North Canberra and seen the new RAAF Staff College plaque. The Association arranged to replace the ageing and damaged original plaque. It looks great, and it will now last for a good many years requiring only minor cleaning and maintenance. I again thank those members who contributed to the cost and also Mac Cottrell for handling the arrangements and Arthur Skimin for arranging the final task of installing the old plaque with the new.

Additionally, I want to record my thanks to current Executive, Mac Cottrell VP, Frank Kelly Secretary, and David Wade Treasurer – we have been a tight bunch of 'managers' for the Association these last couple of years, and I'm sure you too are grateful for that. I express a special thanks also to John Paule who has been the Honorary Auditor for the past couple of years.

We have tentatively set dates for luncheon seminars in 2013 (all Thursdays) March 14<sup>th</sup>, June 6<sup>th</sup> and October 3<sup>rd</sup> (mainly the first Thursday of the month). As we review the financial health of the Association at the 2012 AGM we'll discuss this so that the Executive can implement a change without the need to call an Extraordinary General Meeting.

#### **GENERAL BUSINESS**

#### **Association Luncheon Seminars - Costs.**

- 12. The Treasurer (Mr Wade) advised the meeting that the President had discussed with the Functions Manager of the Royal Canberra Golf Club (RCGC) the current pricing for food and beverages. Each financial year the Club adjusts its prices in line with increases in their costs.
- 13. The Executive was conscious that it didn't want to burden members with the increase of about \$10 per person attending the lunches and examined other possible venue options. While a few venues could provide similar facilities and menus, others were considered to not provide viable options.
- 14. The President put our position on rising costs to the RCGC and they in turn suggested that there was scope for us to make savings on beverage costs and, without reducing the quality of the food component, they could minimise the increases as a concession to our long association with the Club.
- 15. The Executive believed that the quality of the venue, food and services and the ease of arrangements at the RCGC were as good as, if not better than what we could find elsewhere. The meeting discussed the pros and cons of moving venues, including meal and venue costs, and the general view was to maintain the status quo.

- 16. Moved Mr Wade and seconded by AVM Titheridge that:
  - a. the Association continue to use the RCGC as a venue;
  - b. the Executive Committee investigate ways to minimise cost increases in food and beverages without lowering quality;
  - c. the cost of lunch for guest speakers be met from Association funds directly without being included in the overall total cost used to arrive at the individual cost to be charged to members attending luncheon seminars; and
  - d. the Executive Committee for the coming financial year should continue to follow the direction from previous AGMs that luncheon seminars should aim to break even.
